

# COVID-19 release

The undersigned acknowledges the contagious nature of the Coronavirus/COVID-19 and that the CDC and many other public health authorities still recommend practicing social distancing. I further acknowledge that Jessie McKenna and McKenna Academy of Dance have put in place preventative measures to reduce the spread of the Coronavirus/COVID-19 and to protect the below mentioned child.

I further acknowledge that Jessie McKenna and McKenna Academy of Dance cannot guarantee that I/my child will not become infected with the Coronavirus/Covid-19. I understand that the risk of becoming exposed to and/or infected by the Coronavirus/COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to, dance staff, and other dance students and their families.

I voluntarily seek services provided by Jessie McKenna and McKenna Academy of Dance and acknowledge that I am increasing my risk to exposure to the Coronavirus/COVID-19. I acknowledge that I and my child must comply with all set procedures to reduce the spread while attending my appointment.

I attest that:

\* I/my child am not experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.

\* I/my child have not traveled internationally within the last 14 days.

\* I/my child have not traveled to a highly impacted area within the United States of America in the last 14 days.

\* I/my child do not believe I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.

\* I/my child have not been diagnosed with Coronavirus/Covid-19 and not yet cleared as non contagious by state or local public health authorities.

\* I/my child am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.

\* I will IMMEDIATELY notify Jessie McKenna and McKenna Academy of Dance if any of the above changes. I will IMMEDIATELY notify Jessie McKenna of any possible or confirmed Coronavirus/COVID-19 exposures.

I hereby release and agree to hold Jessie McKenna and McKenna Academy of Dance from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act of the dance studio, or that may otherwise arise in any way in connection with any services received from Jessie McKenna and McKenna Academy of Dance. I understand that this release discharges Jessie McKenna and McKenna Academy of Dance any liability or claim that I, my child, my heirs, or any personal representatives may have against the dance studio with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any services received from Jessie McKenna and McKenna Academy of Dance. This liability waiver and release extends to the dance studio together with all owners, partners, and employees.
