

1. It is the expectation that when a student is enrolled, they are committed to attend class regularly until the completion of that season. In the event of withdrawal of classes, a written form of contact must be made with the Studio stating the student is withdrawing.

2. Tuition is paid monthly from September to June. The first payment is made at registration (September) and all subsequent payments will be made through autopay.

3. Should account become substantially overdue, you will receive a letter in the mail asking for payment. After 2 months of non-payment your child will be asked to sit out of class until payment is received.

4. If parents or guardians are divorced and paying tuition separately, both parties must register with the Studio in order to obtain the studio calendar, account information, and for the student to participate in classes.



5. The costume rental fee is collected in the Fall to allow for lower production cost to the families so they do not have to purchase expensive costumes. In turn, the costumes must be returned to the Studio following the final Spring Production performance.

6. If for some unforeseen circumstance a dancer cannot complete a production season, the costume rental fee is refundable until Feb 15.

7. In the event of canceled classes because of inclement weather, if BOTH Dunkirk and Fredonia schools are closed, our studio will be too.

8. If a student misses 50% or more of classes during a production season, they may be removed from the class at the discretion of the Artistic Director and the student's teacher.

9. It is the expectation that parents/guardians check their email for important studio information throughout the year.

10. Students are required to wear their class uniform every day, a black leotard, tights and dance shoes are necessary to participate in class.
